Under Legal Matters Mr. Testino discussed a legal notice that was received for a foreclosure in the City of Rahway that has been sent to Rahway Housing Authority in error. Mr. Testino will contact the proper entities and resolve. Mr. Testino further mentioned the Personnel Policy has been reviewed and signed by all Rahway Housing Authority's employees and will be forwarded to MELJIF.

Under Old Business Mr. Pushko mentioned the status of the City of Rahway's CDBG-DR Grant appears to be moving faster than our FEMA claim for Hurricane Irene.
