

**RESOLUTION OF THE HOUSING AUTHORITY OF THE CITY OF RAHWAY**

**RESOLUTION NO. 1555**

**DATE OF ADOPTION: FEBRUARY 8, 2018**

**SUBJECT: INTERLOCAL SERVICES AGREEMENT BY AND BETWEEN  
THE CITY OF RAHWAY AND THE RAHWAY HOUSING  
AUTHORITY FOR THE MUTUAL PROVISION OF SNOW  
PREPARATION AND RESPONSE**

**THIS INTERLOCAL SERVICES AGREEMENT**, made effective as of the 1<sup>st</sup> day of January 2018 (the "Agreement") by and between the City of Rahway, in the County of Union, a municipal corporation in the State of New Jersey with offices located at One City Hall Plaza, Rahway, NJ 07065 (the "City") and the Rahway Housing Authority of the City of Rahway, with offices located at 165 East Grand Avenue, Rahway, NJ 07065.

**THE FOLLOWING RESOLUTION** was presented by the Executive Director/Secretary at a Regular Meeting held on February 8, 2018:

**WHEREAS**, the City currently provides snow preparation and response services for all of the community's residents; and

**WHEREAS**, the City has the ability to provide such snow preparation and response services including pre-storm brine and salting; and

**WHEREAS**, the Rahway Housing Authority has the need for such services; and

**WHEREAS**, the City and the Rahway Housing Authority have both respectively passed resolutions authorizing Interlocal Services Agreement for the provision of these services; and

**WHEREAS**, the City has proposed, and the Rahway Housing Authority has agreed, that in consideration for such services, the Rahway Housing Authority will help Rahway DPW plow mutually agreed upon designated streets primarily located near Rahway Housing Authority properties when asked to do so by the Director of Rahway DPW; and

**WHEREAS**, the City and the Rahway Housing Authority have each duly authorized their respective proper officials to enter into and execute this Interlocal Services Agreement.

**NOW, THEREFORE, BE IT RESOLVED** that the parties hereto, intending to be legally bound hereby, agree as follows:

**ARTICLE I**

**SCOPE**

Section 1.01. Duties of the City. The City shall provide the services of properly trained personnel as necessary to aid in carrying out snow preparation and response services as described herein below:

- a. Spread brine in Rahway Housing Authority parking areas prior to storm events.
- b. Spread salt in Rahway Housing Authority parking areas when deemed necessary by the Director of Public Works.

The City of Rahway will not charge the Rahway Housing Authority for the materials or labor associated with this work.
